After in persone documents verification at MSPC office, applicant needs to submit online application, upload documents and remit online fees on MSPC online portal https://online.mspcindia.org/ Applicant should then enter payment reference number (DU number) by login on online portal and click on Confirm Application Button without fail after which application status will be seen as complete on dashboard Upon receipt of online application, documents and fees by online mode, as per routine procedure letter will be sent for confirmation of pharmacy education qualification to concerned college/board/university and/or council or appropriate authority. After receipt of positive response as hard copy of letter from them application will be further processed for granting registration number (Registrar-MSPC reserves the right to do additional verifications from appropriate authorities)

Applicants can check status of application using own log in id on MSPC online portal and it may not be possible to give updates on e mail or tracking id of letter as communication between council and appropriate authority is confidential

Approval of application for registration and granting registration number will be done after all above steps are completed. MSPC office always try best to help applicants and complete same as early as possible but **delay in verification and registration may be** possible due to NON receipt of verification report as per required essential points in lines with request letter sent by MSPC from appropriate authority which may be noted

#### <u>New Registration Process w.e.f 21/02/2019 for Applicants passing D Pharm/B pharm/Pharm D</u> from Out of Maharashtra State or Who are Registered Pharmacist of other state and wants to seek transfer to Maharashtra state

FIR was lodged by Thane Crime branch in the month of January 2019 against some registered pharmacists who had allegedly procured bogus documents of 10<sup>th</sup> /12<sup>th</sup> from some persons and secured Diploma in Pharmacy qualification and documents from pharmacy institute (situated out of Maharashtra state) approved by Pharmacy Council of India u/s 12 of Pharmacy Ac t-1948 .It was seen from office records that while granting registration ,said pharmacists had complied with provisions of section 32(2) of Pharmacy Act-1948 and further verification from concerned pharmacy institute / Examination body/ Appropriate authority was received by MSPC office ,upon which registration was granted to them .Necessary steps are taken by MSPC in compliance with section 36 of Pharmacy Act and Pharmacy Practice Regulations in this case against delinquent registered pharmacists.

In light of this incidence, as per provisions of Pharmacy Act ,duties

,responsibilities and rights conferred on Pharmacy Council of India (PCI), New Delhi, State Pharmacy councils and pharmacy institutes and examination authorities approved by PCI u/s 12 were discussed in full council meeting on 8/02/2019. Also correspondence by way of letters done by MSPC with PCI, New Delhi and Maharashtra Government from time to time regarding applicants possessing registerable qualification from pharmacy institute ,out of Maharashtra State or Registered pharmacists of other state, to prevent dilution of profession and to maintain standard of profession in Maharashtra was also collectively discussed and noted. It was conclusively resolved unanimously to take <u>following steps urgently</u> (in addition to present system of submission application documents and in person. scrutiny. and further institute/university/board / appropriate authority verification )to prevent further dilution of profession, in the interest of maintaining pharmacy profession standards in Maharashtra State .The said decision is resolved in the interest of health of public at large as medicines are dispensed by Registered Pharmacists at pharmacies and Registered Pharmacist is important factor in health care chain.

Following changes are implemented from 21/02/2019 and are notified on council website for information regarding set of procedure to be fulfilled by applicant and by MSPC office .

For applicants who are Registered pharmacists of other state are requested to surrender original registration certificate, ID card (if issued ) by other state council with up to date renewal receipt along with above mentioned list of documents . Also submit Affidavit on Rs 100 /- stamp paper solemnly

affirming educational details and other facts, duly notarized (format B available in download section of on online portal)

2) Applicant is required to either get registered with State Pharmacy Councils from where he procured his registerable qualification and produce registration certificate of that council

To submit ELIGIBILITY LETTER from State Pharmacy Councils from where he procured his registerable qualification (Tentative form at given below) (Those who are registered with other State Pharmacy Councils need not produce Eligibility letter)

Applicant is required to produce letter from local police authority regarding no adverse antecedents during study period (Tentative form at given below)
 (Local police jurisdiction during stay of pharmacy course completion period )

4) Till the start of exit exam by PCI, diploma holder applicant needs to appear for evaluation test conducted by MSPC which will be roughly multiple choice question paper with 15 questions based on PCI approved syllabus as per ER. Eligibility criteria, minimum 40 percent along with verbal questions related to pharmacy syllabus and practical training. It is contention that an applicant possessing diploma in pharmacy qualification and certificate should not have any grievance for appearing small evaluation test

#### Action At MSPC level -

1) Immediately request P CI to provide log in id and password to enable MSPC to view the students list uploaded by concerned pharmacy institute on PCI portal

2) It is mandatory that pharmacy College /examination authority confirmation letter mention all confirmations as requested by MSPC. Mere "candidate passed from this institute "reply will not be treated valid for granting registration number

Head of pharmacy institute or Principal or Appropriate authority must additionally confirm that admission qualification for said applicant for said course as per ER 91 is fulfilled by them, the concerned applicant is admitted within approved intake capacity granted by PCI and the institute is approved by PCI under section 12 during admission year of said applicant

3) Keep application received from colleges under OPJS university and Sunrise university on hold and NOT TO accept applications from colleges under OPJS university and Sunrise university with immediate effect till further instructions from council

All concerned are requested to note same and do needful in this regard as early as possible. Both MSPC and PCI being statutory bodies, work within ambit of Pharmacy Act -1948 and respect constitutional norms. At MSPC all members have expressed confidence that all applicants and budding pharmacists who aspire to become registered pharmacists in this state will welcome and adhere to steps initiated by MSPC in the interest of maintaining standards of Pharmacy Profession and health of public at large and this attempt is in no way related to discrimination on grounds of caste, creed or regionalism .


